二零一七年四月十三日(星期四)。參賽作品必須在截止報名日期當日下午五時前遞交至加拿大中文電台多倫多辦事處。 如採用郵寄方式, 郵印日期不能遲於截止報名日期當日。

參賽歌曲之作曲人,填詞人及編曲人共成一個個體,以下稱「參賽者」,於填妥此「加拿大中文電台第十屆中文歌曲創作大 賽」,以下稱「比賽」之參加表格,連同參賽歌曲及報名費遞交之同時,已即時與主辦機構加拿大中文電台(以下稱「加拿大 中文電台」)簽訂具約束力之合約,並作出以下聲明、保証及承諾:

参賽者就此聲明、保証及承諾 :

- 1. 参賽者為加拿大公民、永久居民或已抵埠移民。
- 2. 參賽者並非加拿大中文電台或比賽協辦機構之員工。
- 3. 參賽歌曲之音樂及歌詞全為參賽者之原創作品、並從未經商業性發行。
- 參賽者從未將參賽歌曲之任何版權授予或轉讓他人,亦從未脫離參賽歌曲版權之擁有權、並同意將參 4. 賽歌曲之版權及所有權利無條件授予加拿大中文電台。
- 加拿大中文電台有權更改參賽歌曲之歌詞及編曲,亦有權提供適當之歌手演繹參賽作品。此外,優勝 5. 作品將會被製作成鐳射唱片,並由加拿大中文電台出版,於製作優勝作品成鐳射唱片期間,加拿大中 文電台有權提供適當之音樂編排及歌手演繹。
- 6. 參賽者從未受任何法例所限制而導致其不能參與比賽,或不能遵從相關之所有參賽規則及條例。
- 7. 參賽者並非任何本地、全國性或國際性歌曲創作比賽之主辦者、員工或義工。
- 8. 參賽者確認「第十屆中文歌曲創作大賽」之名稱為加拿大中文電台所擁有,在未經加拿大中文電台同 意下,參賽者不能利用或授權他人利用「第十屆中文歌曲創作大賽」之名稱,與參賽者、其姓名或其 肖像作出聯繫,從而作商業或推廣用途。
- 9. 除非獲得加拿大中文電台之書面批準,參賽者不能於任何時間私自推廣其參賽作品,或授權他人以其 姓名或肖像宣傳其參賽作品。
- 10. 若被獲選晉身決賽,參賽者必須與加拿大中文電台簽署「決賽參賽者同意書」。
- 若晉身決賽之參賽者未能簽署「決賽參賽者同意書」,參賽者將被即時取消資格,並喪失所有比賽 11. 之參與權利,加拿大中文電台無須為此負上任何責任。
- 12. 比賽結果以加拿大中文電台評判之決定為最後判決。
- 13. 參賽者明白及同意加拿大中文電台有權隨時修改或取消比賽日期或地點。
- 參賽者明白及同意對於參賽者之任何損失包括傷亡, 加拿大中文電台無須負任何責任。
- 15. 若參賽者於以上所作出之聲名、保證及承諾有不實或誤導之成分,加拿大中文電台有權取消參賽者之 參賽資格, 且無須為此負上任何責任。

歌曲格式 :

- 歌詞必須為<u>中文(廣東話或普通話)</u>,不能包含任何粗言穢語或仇恨、歧視等訊息或字樣。
- 2 · 參賽者最多可遞交五首參賽作品,每首作品必須獨立遞交參加表格及報名費。
- 每位參賽者最多只能有一首作品,晉入決賽。
- 參賽作品必須包括歌唱部分及 <u>不少於三類樂器</u>之編排,作品長度<u>不能超過四分鐘</u>。提交之樂譜須以黑筆 用五線譜或電腦記譜,音樂之演奏速度、演奏所須時間及樂器編排等必須列明。此外,全部歌詞須另外獨 4 · 立記載。
- 每首參賽作品必須獨立灌錄成 CD / USB Drive (包括一張已完成混音之全首歌曲 CD / USB Drive 及一盒純音 5 · 樂 CD / USB Drive), 連同樂譜(連歌詞) 一併遞交參賽。CD / USB Drive、樂譜及歌詞上均不能寫上參賽者姓 名,並一概不予發還。

加拿大中文電台將保存參加者及演出者個人資料作「第十屆中文歌曲創作大賽」之用。所有資料絕對保密,並將於比賽 結束後銷毀。

By completing this entry form and submitting the same together with the Entry Song and the Application fee for the "Fairchild Radio Toronto 10th Chinese Song-Writers Quest" (hereinafter called the "Quest"), the Composer, the Lyricist and the Song Arranger (hereinafter collectively called "the Contestant") hereby enter into a binding agreement with the Organizer, FAIRCHILD RADIO GROUP LTD. (hereinafter called "Fairchild") and make the following representations, warranties and covenants:

The Contestant makes the following representations, warranties and covenants That:

- the Contestant is a Canadian Citizen or Permanent Resident or Landed Immigrant of Canada; 1.
- 2. the Contestant is not an employee of Fairchild or any other party or entity with which it may co-organize the
- the music and lyrics of the Entry Song are original in their entirety and have never been commercially 3. published;
- the Contestant has not assigned, licensed, or divested in any manner whatsoever of the copyright in the 4. Entry Song and hereby assigns all rights and copyrights of the Entry Song to Fairchild without any further compensation whatsoever;
- Fairchild may alter the lyrics and arrangement of the Entry Song in order that it will be performed at the 5. Quest and provide singer(s) to perform the Entry Song at the Quest. Fairchild Radio will produce and publish the winning entries on CD and Fairchild may also enhance the composition by providing an appropriate arrangement for the composition and singer(s) to perform the Entry Song for the production of the winning entries on CD:
- 6. the Contestant has no legal obligation that would prevent the Contestant's participation in the Quest or compliance with the terms and conditions hereinafter set forth;
- the Contestant is not an owner, employee or volunteer in any other local, national or international song 7. writing competitions:
- 8. the Contestant recognizes that the words "10th Chinese Song-Writers Quest" is the property of Fairchild, and the Contestant shall not ever use, or authorize others to use, the words "10th Chinese Song-Writers Quest" in association with the Contestant's name, person, or likeness for commercial or promotional purposes without the permission of Fairchild;

- 9. the Contestant will not, at any time endorse or permit the Contestant's name or likeness to be used in connection with the endorsement or advertisement of the Entry Song except with the consent, in writing, of Fairchild:
- 10. if the Contestant is selected as one of the finalists, the Contestant will be required to sign a "Finalist's Agreement" with Fairchild:
- refusal to sign the "Finalist's Agreement" will result in immediate disqualification of the Contestant and no 11. further participation in the Quest without any liability on Fairchild:
- 12. the judges' decision of Fairchild is final;
- the Contestant understands and agrees that Fairchild has the absolute right at any time to amend or cancel 13. the date and venue of the Quest:
- 14. the Contestant understands and agrees that Fairchild need not compensate or in any way be responsible for any loss of the Contestant including but not limted to personal and fatal injuries;
- if any of the above representations, warranties and covenants made by the Contestant is false, Fairchild 15. reserves its right to disqualify the Contestant without any liability on Fairchild.
- 16. Fairchild reserves the right to use photographs and videos of all activities and the Quest including but not limited to commercial use.

Song Requirements:

- 1. The lyrics must be in Chinese (Cantonese or Mandarin) and shall not contain any obscene language or message that encourage discrimination or hatred.
- A Contestant may enter up to FIVE (5) works, however each entry must be submitted with an individual 2. Entry Form and Application fee.
- 3. Each Contestant will not have more than one song selected for the Quest.
- A minimum of 3 musical instruments and vocal part(s) must be included in the work. The total duration of 4. each song must be no longer than FOUR (4) minutes. Scores should be clearly written in black ink and notated on traditional staves or formally typed on computer notational software with clear indications on the tempo, duration and instrumentation. A full version of the lyrics legibly written on a separate sheet is also
- Each entry must be submitted on a CD / USB Drive (one track of full mix with vocal and another one with 5. music only) together with combined score and lyrics sheet which shall not display the Contestant's name. All items included in the entry shall not be returned to the Contestant.

FAIRCHILD shall retain the Contestants' and Performers' personal information for the purpose of coordinating the Quest. All information shall be kept confidential and destroyed when the Quest is completed.

This Entry Form is written in both English and Chinese, but in the event of conflict between the two versions, the English shall prevail.
